The Fair Stone team developed in close cooperation with technical experts the international social and environmental standard for natural stones, Fair Stone. Its objetive is to improve the working conditions in quarries and factories of emerging economies.

Fair Stone is a contribution to sustainable globalisation:

- No child labour
- No bonded labour
- Respect of ILO-Conventions
- Safety and health at the workplaces
- Protection of environment and natural resources
- Sustainable procurement
- Decent conditions of global production

Fair Stone strenghtens the demand of customers, public authorities and civil society to procure in a sustainable way and to amplify decent working conditions in the global natural stone sector.





### **Standard Fair Stone**

In our point of view fair trade is based on transparency, dialogue and mutual respect.

Our Fair Stone partners and suppliers contribute to global responsibility by implementing the Fair Stone criteria within their supply chain and thus improve the working conditions in a step by step process.

The standard is based on rules and standards of the International Labour Organization (ILO) as well as the local law. Goods labeled by Fair Stone are free from child labour and forced labour. Furthermore, companies are engaged in a process of improvement in the field of labour security and health of their workers.

The Fair Stone certification program is a step by step process with an ample time schedule that allows even small-scale suppliers to get certified.

The Fair Stone logo helps consumers to recognize natural stones that have been produced under better conditions.

The improvements are monitored and supported by local Fair Stone Representatives and by international experts.

The implementation is documented via a Step by Step Implementation Manual and regular reports.

# **Tracing Fair Stone**

The measures are backed by a certification scheme and the tracking software Tracing Fair Stone. This system tracks each Fair Stone orders from overseas. It documents which enterprise is executing the Fair Stone order, when and where the products are processed, shipped on board, arrive and are delivered in Europe.

Moreover, compliance to the Fair Stone standard is audited by international certification bodies after at most three years.

Stone processing factories and quarries are registered with a special and internal code. The commodities are entered within the system so that the Fair Stone team is informed about current production.

Based on this information the Fair Stone team visits registered factories and quarries unannounced.
